COLORADO

On September 24, approximately 100 British students from Belvedere and 45 Japanese students from San Francisco arrived in Denver. They had an opportunity to sightsee in the Rockies and attended a seminar on the Future of World Unity. Their recent studies of the Divine Principle, Unification Thought, and "Communism, a New Critique" formed the basis for the discussion. The highlight of their visit was the appearance of our **Leader** on the last night of the seminar. This was his first meeting with the Japanese and British students. An audience of over 300 students and family members heard our **Leader** speak on the "True Way of Life." Mr. Salonen likened the charged atmosphere of the evening to a "Day of Hope" lecture. A short question and answer session closed the seminar.

Members of HQ Staff, MU Cdrs, and SRs convened at Belvedere on Tuesday, August 14th for the fifth national conference with our **Leader** and to welcome him on his return from Japan and Korea. Also attending the conference were Mrs. Won Pok Choi, Mr. David S. C. Kim and Mr. and Mrs. Dennis Orme.

Registration and selection of judges for the Lecture Contest took place on Tuesday evening. On Wednesday morning, 48 members participated in the lecture contest and 23 took a written test. Miss Gabriella Rodriguez (SR Oregon) won first place in the contest. Fourteen members scored between 80 and 89 in the contest; 31 scored between 70 and 79. Six of the 23 members who took the written test passed (Mark Pierron, Werner Seubert, Robert Heater, David Endo, Margaret Pease, Leslie Elliott).

The Conference opened in the main house at 10 am on August 15th with **Father** explaining the significance of the day--Korean Liberation Day--marking the 28th anniversary of the liberation of Korea in 1945 after 40 years of domination by the Japanese. FIFTH NATIONAL CONFERENCE OF THE UNIFICATION CHURCH
AND THE ONE WORLD CRUSADE

Belvedere - Tarrytown, New York
August 15, 1973

Attendance: Rev. Sun Myung Moon, Mr. David S. C. Kim, Mr. Neil A. Salonen,

10:00 A.M. SESSION

Opening Address - Master's 40 Days in Japan and Korea

The Conference officially opened at 10 a.m. in the Main House at Belvedere with an address by Our Leader. (Transcription of his talks during the Conference will be printed and circulated.) In his talk, Father explained that God has sent his Son to unite the nations in the Abel position. The Church has reached the level of nation on the spiritual level but also needs a foundation for this on a physical level. In 1972, 1973, 1974 we must go through an indemnity course to pay for this nation and the world. Up to the present, we have taken a defensive position. Now, with the United States in the position of World Christianity, we are taking the offensive.

Father recounted his accomplishments in the 40 days in which he visited Japan and Korea. While in Japan he directed a number of young people in helping a campaign for assembly men. Liberal Democrats hoped to occupy major seats but things happened the other way around so now they recognize their need for our Church.

The high point of his visit to Japan, however, was the blessing of his son, Sung-jin. This represented a great event and mark of victory and brought honor and great joy to the Japanese Family.

In Korea Father had to reassure the Korean Family that he would not abandon them now that he had a permanent residence visa to America. On an external level, he was able to "receive his brother Esau", i.e., to make a substantial donation to the government which is in Esau's position. This reconciliation with the government paved the way for an important spiritual event. Up until now, spirit men have descended to work with particular individuals for a time, after which they had to leave. However, on August 5th, Father conducted a special ceremony in Korea whereby he opened the way for spirit men of his own family, the Moon clan, to work on a tribal level. In that way, it will spread to all other families and reach to the end of the world.

Reflecting on the world at this time, Master commented that as a whole it is burdened by communism, corruption, breakdown of the family, race problems, a decline in Christianity, poverty, lack of a sound philosophy--all grave problems. People see no one able to prevent further decline, all of which will make it easier for them to recognize our group as the savior. Because of us, people will say that the democratic world has hope of being saved and that communism can be prevented from invading. They will see that the Christian world can be restored, that problems of adolescents, black-white problems and other problems can be solved. When government and people recognize that we can solve those problems, the way will be smoothed.

Master repeated that we must acquire a membership of at least 7000. We are something like Elijah--when he thought he was alone, with all others conquered by Baal, he found 70 safe and free from Satan. People will look around hopeless and in distress--then they will see a group of 7000 intact--that this group can save the nation. "These three years we are in the position of Israelites coming out of Egypt. They had to notify every Israelite to leave the land. Before leaving the Satanic land, we must notify all our people."

He continued, "You must know the blessedness of being born in this age, of knowing **Master** and attending him. After things are done you may not find work in which to cooperate with him. You must be grateful that you can pour out your whole energy and being in this work. What you are doing at this moment will be recorded in history--future descendants will ask you what you did during the three 7-year courses. If nothing, while **Master** has struggled to lay the foundation on every level, what will you say? You must be good heirs, inheriting what I have accomplished."

3:00 SESSION

Master's Address on the Need for Unity

After lunch and a break, **Master** spoke on unity between the mobile unit commanders and the state representatives. He said that human effort is not enough. The help of spirit world must be obtained but it depends on our achieving unity. Oneness with another is hard to achieve even for a married couple. It is even more difficult when the SR and MU Cdr are both men. If either is ego-centered, oneness cannot occur. Secondly he said that the purpose of becoming one is to become one with the **True Parents** and then with the nation but not for oneself. "If you do not become one, there is no four-position foundation, so how can God operate? If there is disharmony, you destroy the four-position foundation, the **True Parents** and Heaven--the individual's, family's, and God's purpose. The key is to humble yourself to others. Mutually help, sustain, and love one another." Thirdly **Father** called for sacrifice--"Sacrifice is necessary to achieve oneness. God will protect the person who sacrifices and serves others and will make him an important central figure. Love, hope and life will appear if you are one."

"God loves the person--not the nationality, not the income, not the education--you must not discriminate. Heavenly **Father** looks for beggars--you must inherit the heart of God and not discriminate against such people."

Master said that he was happiest when he was lecturing--"teaching myself as well as others." The physical body needs food--the spirit man also needs food--you must witness and teach. If you are spiritually barren, how can spirit world help you?"

Reports

After **Father's** talk, reports were given by the two IOWC Cdrs, Mr. Joseph Sheftick and Mr. Perry Cordill. SRS and MU Cdrs who had gained the most new members also reported: Mr. Joseph Tully, Mr. Michael Smith, Mr. David Endo, Mr. Robert Williamson, Mr. Charles Anceney and Mrs. Sara Mazumdar. Mr. Kamiyama spoke at 6:30 talking about the Japanese teams working in various states and interpreting some of the cultural differences between Japan and the U.S.

At a 9:00 p.m. session **Master** called on each state to pledge the amount they would contribute toward the \$330,000 budget for the Day of Hope tour. The states in which Our **Leader** will speak were assigned one or more partner states to work with them in preparation for the tour. The session adjourned at 11:30 p.m.
